Sub: Approval to M/s Invotech Precision Engineers, Vishakhapatnam (AP) for conducting specialized course for Competent Supervisors working in Hazardous industries under Section 41-C(b) of the Factories Act, 1948.

Sir,

Reference is invited to your letter No. INVO/DGFASLI/2014-15 dated 25-11-2013 and 04-01-2013 seeking approval of your Training Institute for the purpose of training of Competent Supervisors under Section 41-C(b) of the Factories Act, 1948.

After having examined the matter and the inspection of the institute on 07/02/2014 by a committee constituted by the Director General, DGFASLI, this Directorate General hereby accords approval to the institute for conducting the above specialized training course of one month full time (four weeks)/two months part time (eight weeks) subject to the following conditions.

1. The guidelines as laid down for the above course and as revised from time to time shall be strictly followed.
2. The recognition granted shall be valid for a period of 5 years from the date of the issue of this order.
3. The intake capacity should be a maximum of 30 participants per Batch and the number of batches shall be restricted to five batches in respect of full time course/part time course per annum.
4. You will get the examination conducted by DGFASLI and the certificate to the successful candidates shall be awarded by DGFASLI, Mumbai.
5. The mode of selection and the list of selected candidates for each course shall be intimated to DGFASLI alongwith a certificate of eligibility within one week from the date of commencement of the course.
6. The recognition for conducting the above said course shall be revoked if the Institute fails to comply with any of the terms and conditions stipulated above.
